1. Name:

(i) The College Union of this College shall be called as:

“Nilamani Mahavidyalaya Students' Union” or College Union, Nilamani Mahavidyalaya.”

2. Aims, Objectives and Functions of the College Union:

- (i) To strive for excellence and quality in order to bring about all- round development of the students as well as the college.
- (ii) To organise discussions and deliberation on topics relevant to Social, Cultural, Academic, National and International matters.
- (iii) To organise competitions like debate, essay, group discussions, quiz among the students.
- (iv) To invite and felicitate eminent scholars, prominent academicians, scholars administrators and such other distinguished dignitaries with a view to sharing their vision and getting inspired by their ideals and noble mission.
- (v) To instill in the students a sense of discipline, pride and belongingness to the Institution, so much vital for the growth of the college.
- (vi) To add and assist the Principal/ Authority of the college as and when necessary in various students' welfare programme and other social welfare extension activities.
- (vii) To act as an effective organ of the students at large in ventilating the collective opinion or voice of the students within the frame work of the college rules.
- (viii) To foster unity, integrity and sincerity among the students.
- (ix) To encourage co-operation and co-ordination among the staff and students.
- (x) Last but not least, to ensure best practices among the students in the college in order to help prevail healthy academic atmosphere.

3. Tenure of Office of the College/ Student Union:

The tenure of Office of the College/ Student Union shall be One Academic Year.

4. Membership:

All bonafide students of the Degree wing whose names are on the college roll shall be the members of the Union.

5. Office Bearers:

The following shall be the office bearers of the College Union.

- (i) The President, (ii) Vice-President, (iii) The Secretary, (iv) The Asst. Secretary.

6. **The Principal:**

The Principal shall have the final say over all the matters relating to College Union ; and conducting Annual Election, approving the budgets partly or fully, if necessary, which are already passed by the Executive Committee and carrying on all correspondence on behalf of the College Union with the invitees and guests.

7. **Advisers:**

- (a) There shall be an Adviser and an Association Adviser nominated by the Principal from among the member of the staff.
- (b) The Adviser or the Associate Advisers shall be present in all ordinary meetings of the Union. He will assist by helpful suggestions and the discussion in such matters that he thinks it necessary for the proper conduct of the meeting and organising different activities. The President also may refer to him any Rule for interpretation and the discussion of Adviser in such matters when so referred to shall be final.
- (c) The Adviser or the Associate Advisers may at any time during the meeting at the request of the President explain the scope of a motion or amendment.
- (d) When the Adviser or the Associate Advisers are unable to be present in a meeting, he/she may request a member of the staff to his place and the member shall discharge all the functioning of the Adviser.
- (e) The Adviser or Associate Advisers may preside a meeting whenever is specially requested by the President to do so.

8. **Executive Body of the Union:**

The Executive Body of the Union shall consist of

- (a) President
- (b) Vice-President
- (c) Secretary
- (d) Asst. Secretary
- (e) Class-Representatives,
- (f) Women Representative.
